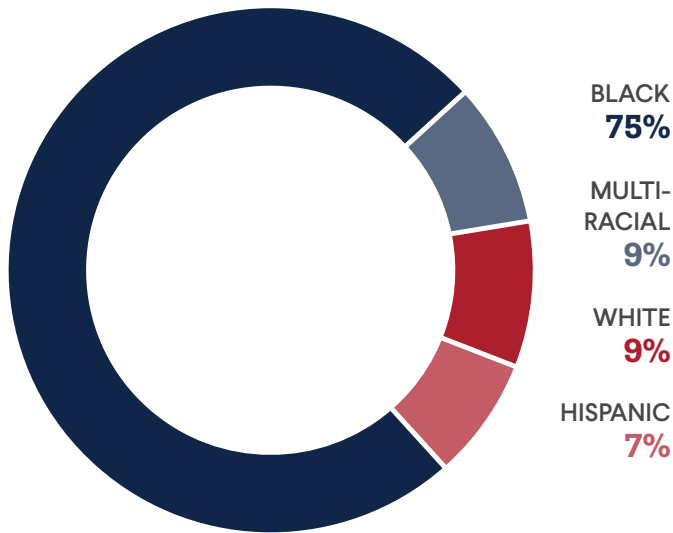

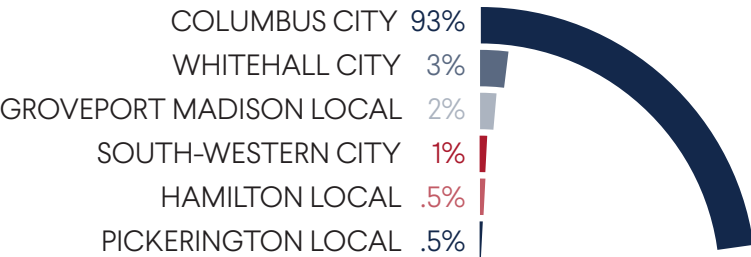

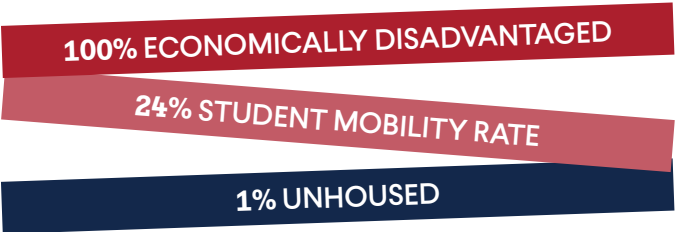
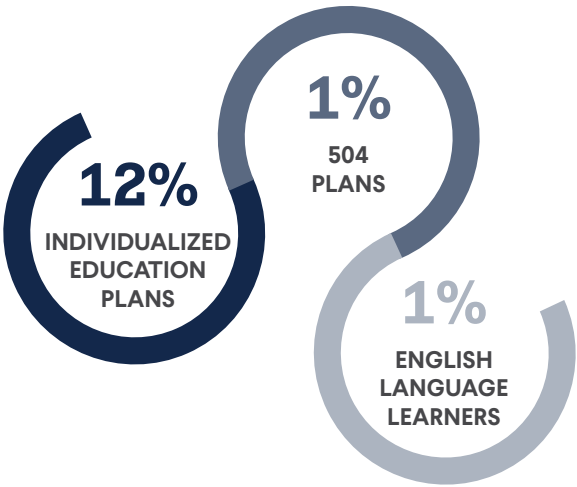
DISTRICTS OF RESIDENCE

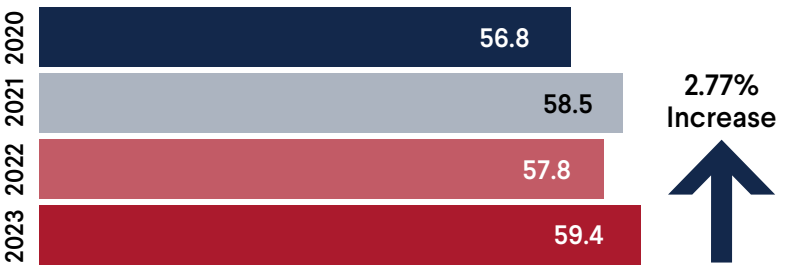
ACADEMIC PROGRESS

The goals of SCPA by 2023 were for:

- 80% of K-2 students to achieve one year of growth in Reading on the i-Ready growth assessment
- 65% of Grade 3-8 students to score proficient in Reading on the Ohio state assessment (or show one year of growth)
- 75% of K-8 students to achieve one year of growth in Math on the i-Ready growth assessment
- 60% of Grade 3-8 students to score proficient in Math on the Ohio state assessment (or show one year of growth)

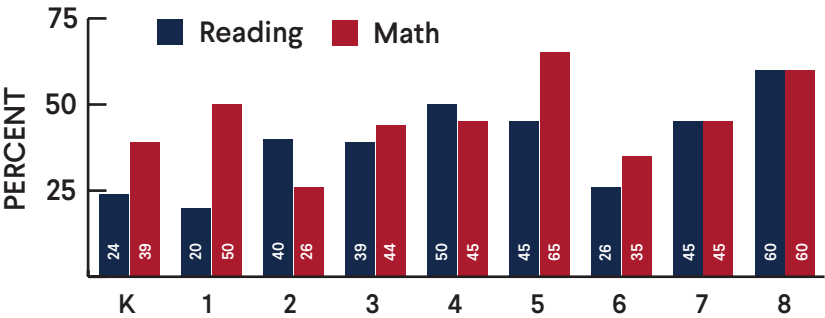
South Columbus Preparatory Academy's academic performance continued to stabilize after pandemic learning loss with a PI score increase to 59.4. The school also earned a 3 star rating on Progress for meeting state expectations in student academic growth. Additionally, SCPA met or exceeded most of its academic goals. 58% of K-2 students and 65% of Grade 3-8 students achieved one year of growth in Reading. 79% of K-2 students achieved one year of growth in Math.
